# 2023 Legislature - Massive Budget, New Regulations

The legislature is heading down the homestretch of the 2023 session. Lawmakers are required to pass the state's biennial budget by the constitutional adjournment date of May 23. DFL leadership and Governor Tim Walz have already announced agreed-to budget targets that would grow Minnesota's two-year state budget to over \$72 billion dollars. This would be an increase of more than 30% over the previous budget cycle. Republicans have decried this growth in government "irresponsible" and "unsustainable".

DFL'ers see this session as a huge opportunity to make investments in the areas of education, environmental protection, and equity programs. They also tout \$3 billion in tax cuts and credits, most of which are targeted to low-income Minnesotans and families with children. The proposed budget also includes billions in new taxes and increased fees in all areas – a retail delivery fee, car registration fees, park entry fees, driver & fishing licenses, and metropolitan sales tax increases, and many more.

In addition to big changes to the state's finances, lawmakers are also eyeing major regulatory requirements and new mandates on business. The most impactful for industry are the substantial changes to standards in the areas of labor and environmental rules.

New labor mandates such as required Earned Sick and Safe Time (ESST) and the new massive Paid Family and Medical Leave (PFML) provisions are moving as stand-alone bills and are expected to be passed by the adjournment date. Other labor changes including, voiding of non-compete clauses in employment contracts, new meat and poultry worker safety requirements, warehouse worker safety rules, expanded lactation rights for nursing mothers, requiring adult-sized

changing facilities, and new workplace ergonomics requirements are all moving forward in large omnibus bills.

The environment bills, particularly the House version, are chock-full of new restrictions. The most impactful may be the restriction and eventual outright ban on the use of PFAS chemicals in the state. There are also changes to compostable labeling requirements, objectionable odor mitigation, restrictions on the sale and use of pesticides and treated seeds, and an energy benchmarking requirement for buildings over 50,000 sq.ft.

Additionally, the MGA team is tracking provisions in the agriculture, commerce, public safety, taxes, and workforce development areas. These include a proposal regarding price gouging during a declared emergency, legalization, and sale of recreational marijuana, the creation of the crime of organized retail theft, the establishment of a 5th tier tax bracket, and happily, continued funding of the Minnesota Grocers Association Foundation Carts to Careers program.

There are differences between the House and Senate omnibus bills and conference committees will need to reach agreements as to which provisions are eventually sent to the governor for his signature, but it is expected that most of the provisions highlighted will become law.

The MGA continues to educate leaders about the impacts of their policy decisions and ensure that the voice of industry is heard. With only a one-seat majority in the Senate, there is an opportunity to impact outcomes. 
# Capitol Check Out >

#### **MGAF Carts to Careers Program**

One great program that the Carts to Careers initiative supports is the Retailer Management Certificate (RMC), which is run by Alexandria Technical & Community College. It is an online, nationally recognized, industry-endorsed, 8-course education certificate. The RMC is an accredited business education program and most participants complete it in two years or less.

Tuition support is available through a State of Minnesota grant appropriation and MGAF funding. The next set of classes begins **May 15, 2023**. The application is open, and the cost-share program makes this an affordable way to provide an educational benefit to your employees (\$2,600 per student). #### **SNAP Updates**

SNAP retailers are required to keep certain staple food items in stock at all times. Items must always be available. If they are not, your store could lose authorization for 6 months. One area



where there have been recent gaps is in the dairy category. See insert to review the requirements and ensure you are in compliance.

#### **Important WIC Update**

As part of the Public Health Emergency that started with COVID-19, MN WIC was given a federal waiver to allow participants to purchase 2% milk in place of skim or 1% milk. This waiver is



ending June 1, 2023, and 2% milk substitutes will no longer be allowed. You can direct participants to check their My Minnesota WIC app for the latest information. **RH**

# WASHINGTON NEWS

#### Congress Returns from Recess to Debt Ceiling Fight

Congress returned to DC from a two-week recess to a full agenda, including continued negotiations over the country's debt limit. Without congressional action, the country will run out of borrowing room by as early as June, according to some estimates. Whether this "x date" falls in June or August, it is clear that Congress must act soon.

In mid-April, President Biden signed H.J. Res. 7 into law, which ended the COVID-19 national emergency roughly a month ahead of the previously announced May 11 end date. The resolution does not have an impact on the COVID-19 public health emergency, which is still slated to end on May 11.

#### **Debt Limit Fight Bleeds into SNAP**

House Republican leadership has begun to unofficially put together a debt-limit package that includes cuts to SNAP. The package would lift the debt limit until May of next year. Republicans are considering a cap on non-defense discretionary spending or a cap on overall discretionary spending to limit budget growth to one percent annually for the next ten years. The GOP proposal would: Institute work requirements for social programs like SNAP to decrease participation and make it harder for states to waive them, rescind unspent COVID relief funds, prohibit student loan forgiveness, and repeal certain green tax credits.

This package is a Republican wish list and certainly will not be agreed to by Senate Democrats. However, Republican leaders hope that this will jump-start debt limit negotiations with the White House.

#### MODERN WIC Act and WIC Healthy Beginnings Act Reintroduced:

Senators Kirsten Gillibrand (D-NY) and Roger Marshall (R-KS) reintroduced the MODERN WIC Act to make WIC benefits more accessible by allowing families to certify and recertify for WIC services remotely. Reps. Brian Fitzpatrick (R-PA) and Suzanne Bonamici (D-OR) introduced companion legislation in the House). During the pandemic, waivers and flexibilities to WIC rules allowed families to enroll or re-enroll in WIC through video or phone and allowed remote issuance of WIC benefits rather than picking up benefits or reloading benefits in person at the WIC office, and this bill would codify these waivers. The bill also provides \$60 million in funding to help WIC offices around the country upgrade technology.

#### Members Urge Congress to Stop the PRO Act

Hundreds of grocers sent letters to Congress urging opposition to the Big Labor bill, the PRO Act. Protecting the Right to Organize (PRO) Act of 2023 carries out a wish list of big labor priorities such as: eliminating state right-to-work laws, limiting work for independent contractors, removing the secret ballot for union elections (i.e. "card check"), requiring employers to provide sensitive employee records to unions, and advancing a litany of other union-backed policies.

#### Labor Secretary Nomination Grows Increasingly Unlikely

President Biden's nomination for Labor Secretary is challenged again. Already opposed by all Senate Republicans, Julie Su's chances to replace Marty Walsh as Labor Secretary have shrunk further. Sen. Joe Manchin (D-WV) told the Biden administration that he has serious doubts about her. This would mark the third failure of a Biden nomination this year. Because of the current Senate makeup, President Biden needs all Senate Democrats as well as the three independents to advance Su's nomination.
