2024 Session – Off to a Fast Start...Again

The legislature opened the 2024 session on February 12 and didn't waste any time in continuing the torrid pace that was set in 2023. As of writing, lawmakers have introduced over 1,600 new bills. These bills bring the number of individual pieces of legislation to a staggering over 8,300 for this biennium, already shattering the previous record which was set in 2019-20. So, not only are these new pieces of legislation on the table, but all of last year's bills are still viable for advancement. Committees began holding hearings on their top-tier issues including a fix to the 2023 tax bill that would have accidentally increased taxes by \$352 million dollars for most Minnesota filers using the standard deduction.

Just days before the start of session, there was a change in leadership. Senator Erin Murphy (DFL - St. Paul) was elected by her caucus members to serve as the new Senate Majority Leader. Out-going Senate Majority Leader, Kari Dziedzic (DFL - Minneapolis), stepped down to focus on her health. The MGA Government Relations Team's thoughts are with her as she continues her fight.

As anticipated, the environment and labor committees have been busy hearing several impactful pieces of legislation. In environment, these include an Extended Producer Responsibility (EPR), drafting a bottle deposit/takeback bill, and a repeal of the current state law that prohibits cities from banning single use bags. These proposals would be extremely disruptive to the entire food industry while being costly for consumers and retailers. They add a complex layer to a recycling system that has proven results.

Labor proposals include adjustments to the previously passed Earned Sick and Safe time (ESST) and Paid Family Medical Leave (PFML) mandates, minimum wage changes, recordkeeping requirements, employee cannabis testing provisions, and a"Retail Worker and Consumer Safety Violence Prevention Act". The Commerce Committees have introduced potential changes to liquor laws (including a bill to allow the sale of full-strength beer in grocery and convenience stores), adjustments to the legalization of adult-use cannabis, and price gouging. On a positive note, the Vendor Collection Allowance bill was introduced. This bill allows retailers to keep a small portion of the sales tax that they remit to the state.

The shortened length of session will certainly mean another faced-paced session where bills move quickly and debate is limited. The MGA Government Relations team is focused on advocating on all relevant issues that are critical for industry. For a successful session, the MGA will need engagement from all members. Hearing your concerns and challenges helps us paint an accurate picture for leaders. Stay tuned for ways to support our collective efforts and answer the call if you receive it. **SB**


2024 MGA Foundation Golf Event & Scholarship Fundraiser

Session until Adjournment Bills are introduced and begin to move through the process.

February Forecast – End of February

The Minnesota Management and Budget will release the state budget forecast for the FY 2025-26 and 2027-28. This will be the number the legislature will use to set any supplemental budget. Governor Walz will release his recommendations for a supplemental budget following the February forecast.

Committee Deadlines

March 22: Committees in both bodies must act favorably on bills that are not major appropriation or finance bills.

April 19: Committees in both bodies must act favorably on major appropriation and finance bills.

Conference Committees

Omnibus bills will be assembled, passed by each chamber, then sent to joint Conference Committees.

Constitutionally Required Adjournment – May 20

The Minnesota Legislature is constitutionally required to adjourn for the year on May 20.

President Biden Attacks Grocery Industry

President Joe Biden recently echoed a familiar campaign refrain in a speech in South Carolina saying "there are still too many corporations in America ripping people off: price gouging, junk fees, greedflation, shrinkflation." His aides hinted these comments are a preview of more pressure Biden plans to levy against large grocery chains. Biden's blame of the grocery industry for higher food prices is a false-confirmation to consumers who believe independent grocers are to blame for higher prices despite recent studies showing increasing margin pressures on independents in the face of higher overhead costs. The MGA continues to educate on industry realities and address day-to-day challenges.

MGA Signs SNAP Choice Letter to Protect Families' Food Choice

The MGA joined a letter as a member of the SNAP Choice Coalition to protect food choice in the SNAP program so participants can continue to choose the grocery items that work best for their families. The letter was in opposition of language in the House Agriculture Appropriations bill that would require pilot projects to test restricting SNAP purchases to only specific"nutrient dense" items.

Credit Card Competition Act Update

U.S. Senate Majority Whip Dick Durbin (D-IL), Chair of the Senate Judiciary Committee and Senator Roger Marshall (R-KS) announced two new co-sponsors to the Credit Card Competition Act: Senators Josh Hawley (R-MO) and Jack Reed (D-RI). The pair joins Senators Peter Welch (D-VT) and J.D. Vance (R-OH) in support of the Durbin-Marshall legislation that would enhance competition and choice in the credit card network market. The bipartisan "Credit Card Competition Act" (S. 1838/H.R. 3881) was introduced to bring competition to the credit card network routing market. Under the legislation, a credit card would be required to have more than one network option on which to route financial data.

Visa/Mastercard Interchange Settlement Information

A settlement was recently reached for the class action lawsuit alleging that Visa and Mastercard, individually, and together with their respective member banks, violated the antitrust laws. If your company accepted Visa or Mastercard credit or debit cards between January 1, 2004 and January 25, 2019, you are eligible. Under the settlement, Visa, Mastercard and the Bank Defendants have agreed to provide \$5.54 billion to merchants. Millions of businesses are eligible and the claims process is now open. Claim Forms have been mailed, and the application process is simple. For more information on the settlement or to find assistance on filing a claim visit <u>www.paymentcardsettlement.com</u>. The deadline to file a claim is May 31, 2024.

USDA Invests in Composting and Food Waste Diversion Projects

The USDA announced the investment of \$11.5 million in 38 cooperative agreements in 23 states that support projects to reduce and divert food waste from landfills and reduce greenhouse gas emissions. The Composting and Food Waste Reduction (CFWR) cooperative agreements is jointly administered by USDA's Office of Urban Agriculture and Innovative Production and the National Institute of Food and Agriculture (NIFA). These 38 cooperative agreement projects will be implemented starting now until 2026.


